
Sun Protection Policy

PURPOSE

The purpose of this policy is to support sun protection behaviours at Portarlington Primary School to minimise risk of health problems from sun overexposure, including skin cancer.

Given schools hours and activities fall within peak UV periods of the day, this policy provides guidelines on effective UV protection strategies.

This policy provides guidelines to:

- support staff and students to use a combination of sun protection measures when UV index levels are 3 or above. Higher risk times are between mid-August (15th) to the end of April (30th) in Victoria.
- ensure that there are outdoor environments that provide adequate shade for students and staff
- ensure students are encouraged and supported to develop independent sun protection skills to help them to be responsible for their own protection
- support our school's strategies to meet its duty of care and occupational health and safety obligations to minimise harmful UV exposure and associated harm for students and staff.

SCOPE

This policy applies to all school activities on and off-site, including camps and excursions. It is applicable to all students and staff.

POLICY

Overexposure to the sun's ultraviolet (UV) radiation can cause health problems including sunburn, damage to skin and eyes, and an increased risk of skin cancer. UV damage accumulated during childhood and adolescence is strongly associated with an increased risk of skin cancer later in life.

UV radiation:

- cannot be seen or felt

- can be reflected off surfaces such as buildings, asphalt, concrete, water, sand and snow
- can pass through light clouds
- varies in intensity across the day and the year with the highest risk from mid-August (15th) to the end of April (30th) in Victoria.
- peaks during school hours.

Sun safety is a shared responsibility and staff, parents and students are encouraged to implement a combination of sun protection measures whenever UV levels reach 3 or above. Information about the daily local sun protection times is available via the SunSmart widget on the school's website, the free SunSmart app, or at sunsmart.com.au or bom.gov.au.

Portarlinton Primary School has the following measures in place for all outdoor activities during the daily sun protection times to help reduce the risk of over-exposure to UV radiation for staff and students.

Shade

Portarlinton Primary School provides sufficient options for shelter and trees to provide shade on school grounds, particularly in places such as:

- where students are seated outside
- over one of our sandpits
- outside our learning spaces (decks and concrete) where we have extended eaves.

Students are encouraged to use available areas of shade when outdoors during peak sun protection times, particularly if they do not have appropriate hats or outdoor clothing.

When building works or grounds maintenance is conducted at Portarlinton Primary School that may impact on the level of shade available to staff and students, a review of the shaded areas available will be conducted and further shading installed as appropriate.

Sun protective uniform/clothing

Portarlinton Primary School recommends that from mid-August (15th) to end of April (30th), and whenever UV levels reach 3 and above, students come to school wearing sun-protective clothing such as:

- loose, cool, densely woven fabric
- shirts with a collar and/or high necklines
- longer style shorts, dresses and skirts
- rash vests or t-shirts for outdoor swimming activities.

Portarlinton Primary School's uniform or dress code applies on and off-site unless otherwise advised. When students are not required to wear school uniform (such as school camps, free dress day), Portarlinton Primary School will ensure steps are taken to encourage students to wear sun-protective clothing whenever UV levels reach 3 and above.

Hats

From August 15th to 30 April, all students **must** wear a sun protective hat that shades the face, neck and ears for all outdoor activities. Hats may also be worn for all outdoor activities outside of the August to April time period, by parent or student choice.

Students wear a school hat or a hat that protects the face, head, neck and ears when outdoors, for example broad-brimmed, legionnaire or bucket hat.

Baseball or peaked caps and sun visors are **not** suitable, as they do not protect the ears, cheeks or neck.

Students who are not wearing appropriate protective clothing or hats will be asked to use available areas of shade when outdoors or a suitable area protected from the sun.

Sunscreen

Portarlington Primary School supplies SPF50 or SPF50+ broad-spectrum, water-resistant sunscreen for staff and students to use and the location is communicated to all staff and students, so it is readily accessible AND/OR Students and staff are reminded and encouraged to bring their own SPF50 or SPF50+ broad-spectrum, water-resistant sunscreen to school.

Sunscreen should be applied in accordance to the manufacturer's directions 20 minutes before heading outside and every two hours, or more frequently if sweating or swimming.

Portarlington Primary School has strategies in place to remind and encourage students to apply sunscreen before going outdoors (eg reminder notices, sunscreen monitors, sunscreen buddies, with time for this scheduled into the daily routine).

Sunscreen that is supplied by the school has the expiry date monitored.

At Portarlington Primary School, if students do not have their own sunscreen, they are welcome to use the sunscreen provided by the school and speak to a staff member to access sunscreen.

Staff and students who may suffer from skin reactions from certain types of sunscreens are encouraged to contact our office on 52592572 to implement a plan to reduce the risk of a sunscreen reaction at school, such as families sending their child to school with a suitable alternative sunscreen.

Sunglasses

Where practical, Portarlington Primary School encourages students and staff engaged in outdoor activities to wear close-fitting, wrap-around sunglasses that meet the Australian Standard 1067 (Sunglasses: Category 2, 3 or 4) and cover as much of the eye area as possible.

Curriculum

Students at our school are encouraged to make healthy choices. They are supported to understand effects of sun exposure and are encouraged to be involved in initiatives to promote and model sun protection measures to the whole school. Portarlington Primary School will address sun protection and UV safety education as part of our Health curriculum lessons in years prep - 6.

Staff role-modelling and OHS

Staff are encouraged to access resources, tools, and professional learning to enhance their knowledge and capacity to promote sun smart behaviour across the school community.

UV radiation exposure is considered as part of our school's risk management and assessment for all outdoor events and activities, i.e. UV radiation protection strategies are included in school camp activities, excursions, sports days and interschool sports events.

Families and visitors

Families and visitors participating in and attending outdoor school activities are encouraged to:

- wear a sun-protective hat, covering clothing and, if practical, sunglasses;
- apply SPF50 or SPF50+ broad-spectrum, water-resistant sunscreen; and
- seek shade whenever possible when outdoors.

Community Engagement

Sun protection behaviour is regularly reinforced and promoted to the whole school community through newsletters, school website/intranet, staff and parent meetings, school assemblies, student and teacher activities and at student enrolment/new staff orientation.

Families, students and staff are provided with information, ideas and practical strategies to support UV safety at school and at home. Portarlington Primary School may provide information through newsletters, noticeboards, school website and social media.
